



Mark Hiznay is a senior researcher in the Arms Division at Human Rights Watch. He conducts advocacy around the UN Convention on Conventional Weapons, the Mine Ban Treaty, and the Convention on Cluster Munitions. He has authored and contributed to numerous Human Rights Watch publications. Since January 2000, Mark Hiznay has worked with Landmine and Cluster Munition Monitor. Before joining Human Rights Watch in 2000, Mark Hiznay was a consultant to US government agencies and worked on treaty negotiation and implementation, strategic offense arms elimination, on-site inspection operations, and national landmine policy. He received a B.A. in International Studies from Norwich University (the Military College of Vermont) in 1989 and graduated from the George Washington University's Security Policy Studies program with a Master's degree in 1992. Mark Hiznay is the final editor of the Landmine Monitor 2012.

Stephen Goose, director of Human Rights Watch's arms division, has been at the forefront of international efforts to address the humanitarian dangers of cluster munitions, helping to bring about the Convention on Cluster Munitions agreed in Dublin in May 2008. Stephen and Human Rights Watch were instrumental in bringing about the 1997 Mine Ban Treaty, the 1995 protocol banning blinding lasers, the 2003 protocol on explosive remnants of war, and the 2008 Convention on Cluster Munitions. He and Human Rights Watch co-founded the ICBL, which received the 1997 Nobel Peace Prize. Before joining Human Rights Watch in 1993, Goose was a staff member of the House Appropriations Subcommittee on Foreign Operations and a researcher at the Center for Defense Information. He has a master's degree in International Relations from the Johns Hopkins School of Advanced International Studies and a B.A. in History from Vanderbilt University



Loren Persi is a victim assistance thematic editor with the Landmine and Cluster Munition Monitor. He has been involved with the Monitor since 2003. Loren Persi also contributed to the annual reporting for the Working Group on Victim Assistance and Handicap International Belgium publications on the human impact of mines, cluster munitions and other explosive remnants of war, and on efforts to assist survivors, their families and affected communities. Loren Persi has a B.A. in Development Studies and a B.A. in Asian Studies.

Stuart Casey-Maslen is the mine action thematic editor for the Landmine and Cluster Munitions Monitor. He holds a doctorate in international humanitarian law from the University of Tilburg in the Netherlands and a master's degree in international human rights law from Essex University in the United Kingdom. He jointly edited a legal commentary of the Convention on Cluster Munitions, which was published by Oxford University Press in 2010, and his legal commentary of the Anti-Personnel Mine Ban Treaty was published by Oxford University Press in 2004.
